1. Call to Order: 10:35
2. Determination of Quorum: A quorum (26 votes) was determined.
3. Approval of Past Meeting Minutes: Annual HOA Meeting – September 21, 2024
  - a. Minutes of the 2025 annual meeting were presented and summarized by D. Raimond, secretary.
  - b. The minutes were approved as presented.
4. Treasurer's Report:
  - a. The report was presented and summarized by H. Beliveau, treasurer.
  - b. The report was approved as presented.
5. President's Report : Legal Counsel Communications
  - a. M. Melton, president, and H. Burns, 2<sup>nd</sup> VP, have met with Karen Mitchell of the Averra Law Firm of Dripping Springs. Ms. Mitchell is very knowledgeable in HAO laws.
    - i. Resale certificates are provided to realtors.
    - ii. The 5-acre, or original plating, restriction states that no lot can be subdivided.
    - iii. The bylaws state that no business can be run from the property, so no short-term rentals would be permissible; however, long-term rentals are by law permissible.
  - b. The HO Management certificate has been updated and filed with the state.
  - c. New open meeting laws require a 144-hour (6 days) notification of meetings including board meetings.
    - i. Any property owner may attend any of the meetings.
    - ii. Notices will be posted on Facebook, on the website, with signs on each street, by email, and/or by mail
    - iii. New voting laws state that any property owner may vote regardless of dues in arrears.
6. Committee Reports
  - a. Architectural Control Committee:
    - i. No current reports of construction.

- ii. Please remember if you are planning any structural changes to existing buildings or fencing, the architectural committee must be contacted for approval.
    - 1. Square footage for homes is a minimum of 1350 square feet.
    - 2. Buildings should be a minimum of 30 feet from property lines.
    - 3. M. Melton will check on the easement requirement from the center of the road.
- b. Maintenance –
  - i. County Road Work: The county has completed road maintenance.
  - ii. Burn Ban Communications:
    - 1. H. Burns provided a handout with helpful tips on burning brush and wildfire preparedness.
    - 2. Check with the sheriff's office for burn ban status.
    - 3. Please continue to post on Facebook when you burn brush.
    - 4. R. Pegram stated that Texas AM has an excellent website on fire management and resources. A link to the website will be posted on our website.
  - iii. Complaints: If any property owner has concerns, they should contact H. Burns, 2<sup>nd</sup> VP.
